Terms:

1. Booth owner(s) is only allowed to be at the booth 1 hour prior to the show and 1 hour after the show. You are unable to use flashing lights, any type of sound, and huge banners that would conflict with the show. The producer of the show will have full right to notify the Booth owner(s) what is not acceptable with the accordance of the show.
2. Reasonable precautions will be taken by the producer to protect persons and property during the show; however, neither producer, facility, nor representatives of any of the same, shall be responsible for the personal safety of Booth owner(s) or its representatives neither from injury, nor for the safety of the property of the Booth owner(s) from theft or damages. All changes to the event will be notified to the Booth owner(s) via telephone as well as in writing via electronic mail.
3. In the event of extreme weather conditions, fire, casualty, disaster, labor disputes, acts of God, or any other emergency situation beyond the control of producer, producer will, at its discretion, reschedule and/or procure alternate space for Show. Booth owner(s) agrees that the terms and conditions set forth in this agreement shall apply to any rescheduled date and/or relocation, and producer shall not be liable to Booth owner(s) for any loss or damage suffered by Booth owner(s) by reason of such rescheduling and/or relocation of Show.
4. Booth owner(s) s release all rights to all photographers, video crew, and guests and media crew present at the event who may be taking photos or video taping the outfits provided by the Booth owner(s) . The Booth owner(s) agrees to give proper credit on all videos, photos etc. that are put up or distributed by the Booth owner(s). Each photo/video must include such information as "The Economic Development Forum 5 Series Holiday Shopping Spree Event by Skylier Wear (www.skylierwear.com)".
5. Shall litigation be necessary for producer to enforce any condition of this agreement, producer, in addition to any damages or relief awarded, shall be entitled to receive interest at the rate of three percent (3%) per month from the date of breach, court costs, and attorney's fees of one half of the Booth owner(s) fee. Booth owner(s) agrees that jurisdiction, venue, and choice of law shall be in the State of California.
6. The agreement between producer and show facility shall supersede the agreement between Producer and Booth owner(s). Any promotional and/or instructional information provided by producer to Booth owner(s) is accurate as of publication; however, producer reserves the right to change or modify details of the Show without notice. Producer may issue additional rules, or amend any existing rule, as it deems necessary for the orderly presentation of Show, provided such addition or amendment does not substantially diminish the right or increase the liability of Booth owner(s).

Booth owner(s) agrees to indemnify and hold harmless producer, facility, and representatives of the same, for all claims by Booth owner(s), Booth owner(s)'s agents, employees, contractors, or by any other person, arising out of any act or omission in any way related to Booth owner(s)'s participation in show. Booth owner(s) waives, without limitation, all claims for damage, destruction, loss or theft, personal injury and any other act or failure to act of producer.
9. This agreement shall represent the entire agreement between Booth owner(s) and producer. Producer shall not be bound by any representation or understanding not expressly set forth in this agreement. No provision of this agreement shall be modified except by the written mutual consent of the parties. Booth owner(s), in signing this agreement, or having same-signed representative, acknowledges his, her, or their authority to do so and hereby assume liability for the terms, conditions, and amounts stated herein. If any clause of this agreement is found to be invalid or unenforceable, the remainder of the agreement shall continue in full force and effect without regard to the invalidated clause.
